Obligations of a Licensed Operator to Turbo Touch Ltd.

Successful applicants will be required to enter into a License Agreement with Turbo Touch Ltd and abide by the terms and conditions of the agreement. A copy of the agreement will be available for inspection

The full obligations of the Licensed Operator, along with all terms and conditions of the License are contained in the License Agreement. Examples of some of the obligations contained in the License Agreement are listed below:

- Only certified Turbo Touch® referees are to officiate games.
- Turbo Touch® official referee clothing must be purchased and worn by all referees.
- Turbo Touch® official ball and bibs must be used. (2 sets of bibs and 2 balls are given to the licensee Free of Charge as a starter kit). Others must be purchased from Turbo Touch Ltd.
- The Licensee must use a the Turbo Touch reporting system to administer and report on any Turbo Touch competition. Turbo Touch Ltd will calculate the license fees payable using the information in the Turbo Touch Reporting System and issue and invoice to the Licensee.
- A Turbo Touch® branded webpage with draws and results, at a minimum, must be provided to the players. If the Licensee does not have a website the Turbo Touch Web Application must be used to provide this.
- The Turbo Touch® playing area must be marked up as per the court specifications described in the rules. If such space isn't possible then Turbo Touch Ltd must approve the variance and agree to any modification of the rules required.
- Any license granted may not be sublicensed to other parties or venues.
