CITY OF QUESNEL BYLAW NO. 1845

A bylaw to amend the City of Quesnel Zoning Bylaw No. 1662 (2009).

WHEREAS the City of Quesnel wishes to amend Zoning Bylaw No. 1662 (2009) pertaining to cannabis production and the retail sale or distribution of cannabis;

NOW THEREFORE the Council of the City of Quesnel in open meeting assembled enacts as follows:

- 1. Schedule "A" of City of Quesnel Zoning Bylaw No. 1662 (2009) is hereby amended by:
- a) Adding the definition of "CANNABIS" under Section 3.1 (Definitions) as follows:
 - **"CANNABIS"** means cannabis as defined in the *Controlled Drugs and Substances Act* (Canada), or any regulations made pursuant to that Act, and includes any products containing **cannabis**.
- b) Deleting the definition of "MARIHUANA PRODUCTION" under Section 3.1 (Definitions).
- c) Adding the following definitions under Section 3.1 (Definitions) in alphabetical order as follows:

CANNABIS PRODUCTION means premises where **cannabis** (whether medical or recreational) is cultivated, propagated, harvested, tested, produced, made, sorted packaged, imported, exported, destroyed, transported, shipped, or delivered as regulated under the Controlled Drug and Substances Act, including the Marihuana for Medical Purposes Regulations or any subsequent legislation for the purposes of retail.

CANNABIS STORE, GOVERNMENT means a retail store established by the government under the Cannabis Distribution Act, as amended or replaced from time to time, for the sale of cannabis and cannabis accessories to consumers, and for certainty, does not include a Licensee Cannabis Store.

CANNABIS STORE, LICENSEE means a retail store licensed under Part 4 of the Cannabis Control and Licensing Act, as amended or replaced from time to time, for the sale of cannabis and cannabis accessories.

- d) Add to the list of permitted uses under Section 22.1 the following text:
 - .29 cannabis store, government
- e) Add as Section 22.9 the following text:

A cannabis store (government or licensee) will not be permitted within: a) 1000m of another cannabis store; b) within 50m of a secondary or junior school; c) within 100m of a playground or playfield; or d) within 30m of a residentially zoned property.

d) Add to the list of permitted uses under Section 20.1 the following text:

.27 cannabis store, government

e) Add as Section 20.6 the following text:

A cannabis store (government or licensee) will not be permitted within: a) 1000m of another cannabis store; b) within 50m of a secondary or junior school; c) within 100m of a playground or playfield; or d) within 30m of a residentially zoned property.

- e) Add to the list of permitted uses under Section 28.1 the following text:
 - .4 cannabis production
- e) Deleting Section 4.22.3 and replacing with the following text:
 - .1 **Cannabis Store, Licensee** is a prohibited use in all zones within the City of Quesnel.
- 2. This Bylaw may be cited for all purposes as "City of Quesnel Zoning Amendment Bylaw No.1845 of 2018".
